INSPECTION/ABATEMENT WARRANT

20 THE PEOPLE OF THE STATE OF CALIFORNIA TO THE DEPARTMENT OF
21 FOOD AND AGRICULTURE AND TINA GALINDO IN HER CAPACITY AS
22 PROGRAM SUPERVISOR FOR THE GYPSY MOTH PROJECT IN OJAI.

23 Upon good cause shown to the Court:

24 You are hereby commanded to conduct an inspection and take such abatement action as is
25 authorized by the Proclamation of an Eradication Project regarding gypsy moth, issued by the
26 California Department of Food and Agriculture on February 11, 2008 ("Proclamation"), in the
27 City of Ojai, Ventura County, in those portions constituting approximately 267 acres as shown on
28

1 the map attached, and generally bound by South Rice Road, Camille Drive, West Lomita Drive
2 and South La Luna Avenue. The purpose of this Inspection/Abatement will be to inspect the
3 exterior areas of said properties for any evidence of an infestation or any areas in which gypsy
4 moth might be in existence, and to eradicate gypsy moth. Notwithstanding any finding, you are
5 authorized to take such actions pursuant to Food and Agricultural Code section 5763 as may be
6 necessary to eradicate within the properties, according to the Proclamation.

7 The warrant is effective from the date hereof for a period not to exceed sixty days, unless
8 extended or renewed, and it shall be returned to the judge whose signature is affixed below.

9 Said inspections can commence on the day succeeding the issuance of this warrant
10 beginning at 8:00 ^{and ending @ 5:00PM on each day} a.m. and you are authorized to execute this warrant whether or not the property
11 is occupied at the time of your arrival for execution.

12 You are authorized to use such reasonable force as is necessary to gain entry to the exterior
13 premises to which the warrant pertains.

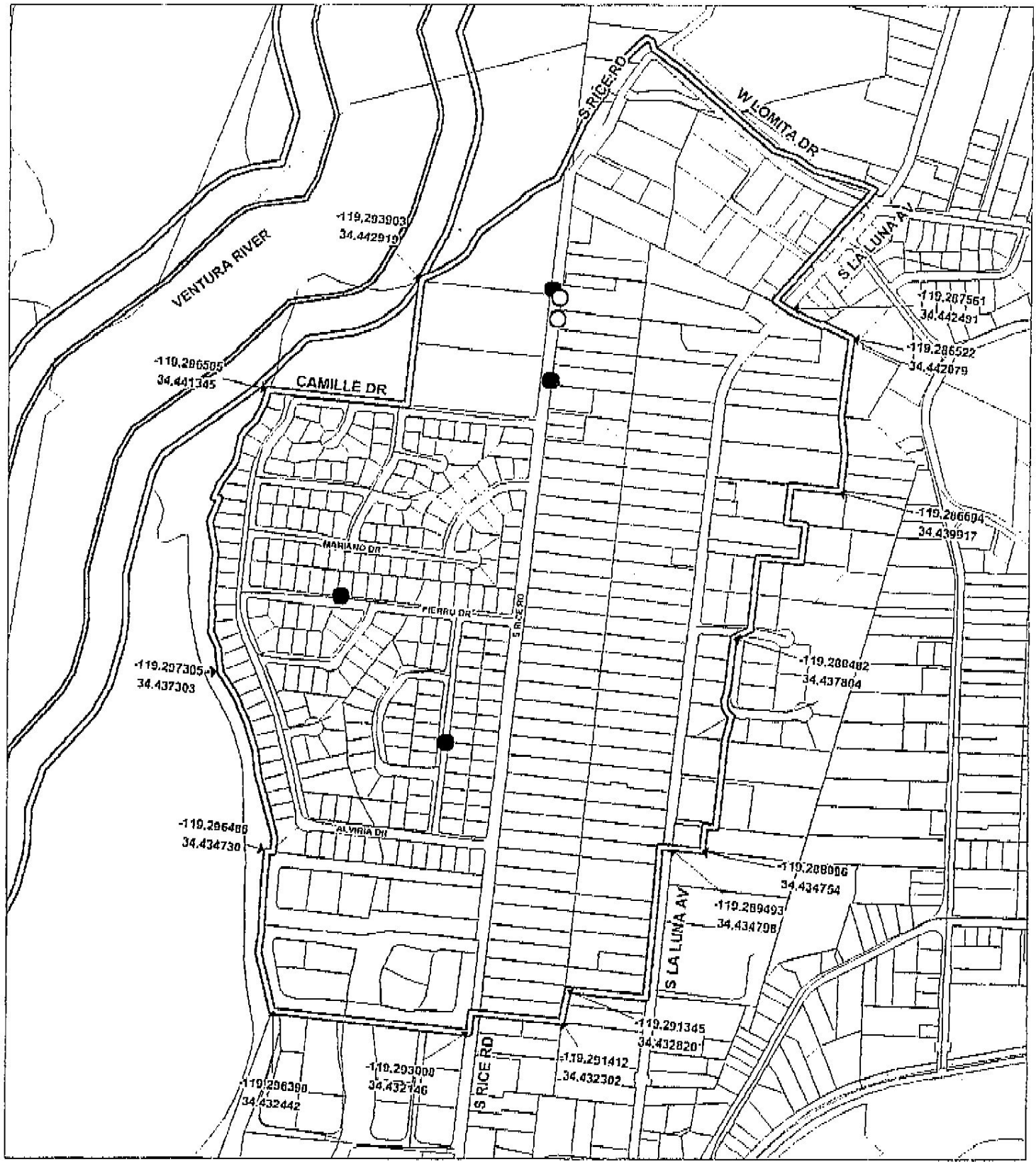
